A.2 Highlights of main achievements per group of activities

The interim report period, especially the financial section of the reports, and their certification process by FLCs were not completed on time. In fact, one of our partners' financial report was not examine yet.

The fourth project progress report was prepared just after the interim report. The project activities were completed about 45% till now. The interim report and fourth progress report activities and their timing were overlapped. The project procurement plan (Annex 7) of the LitOUTer project was attached. The activities are listed below;

<u>Management:</u> Up to the present progress report, 40% of the Management was completed. The main subject of this period was the preparation of the interim report especially the financial section of the reports and submitting it to the FLC and getting the certificates from FLCs. The FLCs examinations were done successfully. Each narrator report submitted by partners' submissions was compiled as a project interim report and submitted.

LP:

- 1. The project interim report was prepared.
- 2. Two partner meetings were organised to discuss interim report preparations and action to be taken (LP-Attachment-Partner meeting PR-4).
- 3. Play cards were prepared and printed by means of, questions, puzzles, figures, etc., by external experts (teachers, designers, etc.) and project team guidance.
- 4. The play cards were sent to the partners. Each partner has 640-645 sets of play cards (2500 set puzzles, 10000 playcards in total). Each set has 15 question cards, 4 play cards and 20 puzzles, one manual (how to play) page, one content page, one scorecard, and one player scorecard.
- 5. The playcards were produced in five different languages, English, Turkish, Romanian, Bulgarian and Georgian (LP-Attachment-Playcard- PR-4).
- 6. The posting budget of the playcards to the partners was supplied by LP office and administration budget line. During the project preparation period, this budget item could not take into consideration in the budgetline unfortunately.
- 7. Preparation of the tender Dossier for "GA.T.3. Demonstration model for mapping of disperse/diverse of the marine litters and future trends" was prepared and submitted according to the Prag and National tender rules.

8. The first progress report of the GA.T.3.was taken from contractor company (DATAKENT) at January 2022. The studies of the senarios have been continuing (LP-Attachment-Modelling GA.T.3-PR-4).

IBEDC:

- 1. IBEDC have conducted 4 stakeholders(Children/adults) trainings in the target region of Adiara:
- 2. IBEDC have purchased awareness/training/meeting materials were bought after market research;

MN:

- 3. Prepared and submitted the interim report and received the FLC certificate.
- 4. Participated at partner meeting that took place after the workshop in Trabzon and at one organized online.
- 5. Prepared an integrated report for trainings organized under GAT4, with all partners trainings information, which will be used by LP at the interim report.

IO-BAS:

- 1. Training course under GA.T.4.3.1. have been conducted on 13.10.2021 with participation of young people (12) part of the Arlekin theatre-Varna team.
- 2. Contribution with raw GIS data to the T3 Demonstration model for mapping of disperse/diverse of the marine litter and future trends. Under this activity, the team of IO-BAS started to collate specific information to be incorporated into the hydrodynamic model. The data obtained and processed from the expedition of IO-BAS aiming marine litter on the sea bottom (GA.T3) were sent to the LP for further consideration toward model elaboration.
- 3. Popularization of the project activities and results among the students from Shumen University K.Preslavski (GA C).
- 4. Play cards were received from Customs Varna and will be distributed during the training courses among participants.

- 1. Attending online the Steering Comitee meeting organized by the coordinator (PP1, KTU) in Trabzon, Turkey during 07-08 October 2021

- 1. BSNN conducted regular internal management team sessions and coordinated work on project activities. BSNN took part in all partner meetings on project level as for example the meeting on 13 January 2022.

No activity was done in this period.

- 2. Had 2 meetings with stakeholder from various institutions that are related with the topic of marine litter.
- 3. Designed the project materials (play cards) in Romanian language.

No activity was done in this period.

NIMRD:

- 1. Two (2) banners, one (1) roll-up, 625 brochures, 625 leaflets, 100 posters, and 50 stickers were produced (NIMRD-Attachment-1 DT.2.3.1.Awareness Materials-PR-4 and NIMRD-Attachment-2 Awareness materials-PR-4.
- 2. Awareness materials for children consisting in 65 t-shirts and 65 hats were prepared (NIMRD-Attachment-DT.2.3.1.Awareness Materials-PR-4, and NIMRD-Attachment-2 Awareness materials-PR-4).

BSNN:

1. GA D.T2.2.1 activities continued successfully with another series of 5 trainings/meetings (68 participants): 1 in Varna on 12.11.2021 (17 participants) - training of awareness promoters - representatives of FLAGs (Fisheries local action groups), NGOs, marine cluster, sea going professions, environmental activists, EU information centre etc. Project messages and project awareness toys introduced to

help awareness activities; 3 in Burgas (on 6.12.2021, 8.12.2021 and 13.12.2021 with 18, 11 and 8 participants respectively - trainings and awareness raising activities for teachers, parent volunteers, activists - small presentation about solid waste, plastics and marine litter, planning of outdoor activities for youth and children; 1 online meeting for Varna, Dobrich and Burgas partners and associates on 29.01.2022 (14 participants) to introduce recent data on marine litter and plastics pollution and discuss responsibilities of politicians and consumers (ref. templates with reports on trainings) (BSNN-Attachment GT.2.2.1-PR-4).

2. Toys (260) disseminated to children and students in places all along the coast (Varna, Burgas and other smaller towns and villages), leaflets and brochures disseminated.

- 3. The firm that won the tender was produced first progress report. The report consisted of;
- 4. a) General information of the Black Sea, and specifically four river basins in four partner countries. These rivers are; Choruh, Georgia; Sürmene, Türkiye; Kamchia, Bulgaria and Danube, Romania (LP-Attachment-Modelling GA.T.3-PR-4).

GAT4: Up to present progress report 50% of the total project activities have been completed

LP:

- 1. GT4.2.1. There were big organisation done in this period. Training activity was organised in high school (88.Cumhuriyet High School). In total, more than 550 students were participated at the meeting either face to face (in the meeting hall) or online (linked from their classes). The face to face training activity was repeated twice (LP-Attachment-GAT2 and GAT4 visit-training-PR-4).
- 2. GT4.3.1.One fishermen and one women training activities were done in this period (LP-Attachment-GAT2 and GAT4 visit-training-PR-4).

IBEDC:

- 1. A.T.4.2-IBEDC have held 2 offline (face to face) trainings in schools (2), while trainings 51 school children were trained about raise awareness in marine litter issues. They got useful information and introduced with essential issues of marine litter.
- 2. A.T.4.3.- IBEDC have held 2 trainings for raising awareness of adults, with participation of 76 persons (General Public-Local Population and Housewives of Chorokhi river) that found out more information about marine litter and their impact on marine environment. Also, they suggested actions that can be implemented on the beach to make people keep the beach clean and to inform them about marine litter aspects.

- 5. The training activities of stakeholders (activity AT4.2 and AT.4.3) are in progress and depend by the national safety regulations. Due to Covid-19 pandemic restrictions in 2021 and 2022 in Romania, the training focused on local people and decision makers such as citizens, local school teachers, and children in the local areas will be done in the next of period of the project implementation. Up to now 4 schools were already identified and preparing for training around 150 children starting in March 2022 (NIMRD-Attachment-DT.4.3.1. Training PR-4).

BSNN:

- 1. GA T4 D.4.2.1 activities involved 7 trainings/meetings (283 participants) in the current period as follows: 1 training for nursery school in Varna on 11.11.2021 (30 children) with series of activities related to use of awareness toys, pictures; 1 training in Burgas on 06.12.2021 (11 children 1st 5th grade) with awareness material and toys; 1 training in Burgas on 08.12.2022 (5 groups 3rd and 6th grade with 27,18, 16,18,13 respectively) with awareness materials, presentations and toys; 1 training in Burgas on 10.12.2021 (3 groups of students 2nd to 6th grade 14,20,9 respectively)-with awareness materials, presentations and toys; 1 training in Burgas on 13.12.2021 (4 groups of students 1st to 3rd grade 19,20,13,22 respectively) with awareness material and toys; 1 training in Burgas on 14.12.2021 on 14.12.2021 for 10 children, mixed group of primary and secondary school students; 1 training in Burgas on 15.12.2021 for 23 students, 6th grade, awareness materials, presentations and toys. Target number of meetings and participants has been achieved and surpassed (BSNN-Attachment-GT.4.2.1-PR-4, and BSNN-Attachment-GT.4.3.1 PR-4).

GA T4 D.4.3.1 -activities involved 4 meetings for locals in the coastal regions of Varna and Dobrich for a total of 150 participants: 1 in Varna region on 31.10.2021 for 56 people; 1 in Ezertz, Dobrich region on 31.10.and 6.12.2021 for 14 people; 1 in Kavarna Dobrich region hybrid online and physical presence for on 29.10.2021 for 50 people, and 1 in Byala, Varna region on 6.12.2021 for 30 people. All meetings focused on general awareness messages, dissemination of awareness materials including toys, outdoor activities, coastal clean-ups, marking of IBSD 2021 and St. Nicholas Day (BSNN-Attachment-GT.4.2.1-PR-4, and BSNN-Attachment-GT.4.3.1 PR-4).

A.3 Project Specific Objectives

Project Specific Objectives Explanation on the level of achievement 1. Raising awareness and LP: Visiting of the project team to the stakeholders and local responsibility of the stakeholders folks have been pushing their awareness about their environment to reduce marine litter and also how their behaviour can impact on the environment. Nowadays the project team use the slogan "DO'NT THROW" and "ONE PERSON DO, ALL DO". We touched one teacher soul about diminishing litter pollution in the school, the environment of the school and more, and she put the first level to train her students and their family. She organised many activities. She organised whole school student and also school manager to get training meeting. She got recycling bins from municipalities. She controls everyday if the bins are filling or not and she warned the students. We touched one teacher soul, and she is changing her school environment. This is a success story of the project. **IBEDC:** While the reporting period of the project, part of stakeholder manager units were visited and were explained our project activities. They were all agreed and they were declared to support our activities. They were also given some idea about how we can reach more easily to their sectors. The activities according to the different stakeholder groups were planned. In a short while, the field studies will be started. The aim of delaying these activities is that we may have a chance to do face to face with our stakeholders after diminishing pandemic limitations. In both situation, we will continue to training activities in April 2022 MN: all the activities implemented during the project are contributing to increase the awareness of stakeholders, especially when you use concrete examples and when you put them directly in contact with the problem of marine litter. **IO-BAS:** During the reporting period IO BAS (according to GA T4) young actors and students agreed and declared the support of our public awareness activities. Advertisement materials and toys were distributed among them stressing the fact of marine litter could jeopardize the life at sea. NIMRD: Since the project started, all stakeholder manager units

were visited and were explained our project activities. They were all agreed and they were declared to support our activities. They were also given some idea about how we can reach more easily to their sectors. The activities according to the different stakeholder groups were planned. In a short while, the field studies will be started. The aim of delaying these activities is that we may have a chance to do face to face with our stakeholders after diminishing pandemic limitations (wave-4 and wave-5 of COVID-19 Pandemic in Romania). In both situations, we will re-start training activities in March 2022.

BSNN: Considerable progress has been made in raising the awareness of key stakeholders promoting improvement in waste management practices, adoption of good practices for marine litter reduction, change in consumer attitudes and awareness of businesses and producers' responsibilities for sustainable use of resources. The partner organised 16 meetings and trainings with total of 501 participants from different places along the coast, different age and stakeholder groups, disseminated over 1000 awareness and publicity items (toys, t-shirts, posters, leaflets, brochures), issued 4 press releases, supported over 10 media publications, as well as social media posts in thematic groups. Substantial progress in achieving objective 1.

Determination of the proportions of the potential sources for the marine litters LP: In the project, seasonally sampling are doing. This is a guide for the determining of the sources of the marine litter. Sampling for this study show us, litter pollution situation and changing on river and beach. Results will demonstrate to us the resources and the impact.

MN: Marine litter case studies carried out on the beach are contributing to the process of seeing the situation on Romanian beaches, but are not especially seeing the potential sources, can be only assumptions can be made. All the dates/information are entered in Emodnet database.

NIMRD: After the literature survey in the first progress report, there were no activities for this. We have an in-house supported project related to riverside and seaside litter collection project are supporting this project with its results.

BSNN: The partner is preparing for field studies in the spring, summer and autumn of the current year. The partner team is making a review of available information to select sample area and plan how to describe the marine litter sources, ways of transport and options for field studies to measure quantities and top pollutant items. Considerable progress in achieving objective 2.

 Development of methods for mitigation and determination of cleaning strategies of marine litters LP: During the training activities, participants asked many question about the difficulties of the diminishing the litter pollution. They could not solve the problem. Then we advised and shared them our knowledge and methodologies. They found reasonable. Some of the participants were also found their way which was very good to the diminishing litter pollution. In fact, most of them were not believe can be stopped the litter pollution.

They thought their impact were not important to produce litter and also to solve the pollution. The project team are crashing down this idea and are building a new perspective like "one person do, all do".

MN: These methods will be developed after the activities carried out with stakeholders (like workshops), but also after the trainings for them. Also, the open air exhibitions will represent an important factor in order to see the citizens perspective.

IO-BAS: We count on the curiosity and the need of the young people te get known more about the marine litter problem and how reduce the impact on the environment.

NIMRD: When the awareness activities will start in the sampling area, together with the other activities (extra bins, separation of litters (at least plastics, papers), the awareness level will be improved. The awareness studies planned to be carried out in the sampling area will be increased with the support of decision makers (such as, extra bins, recycle bins etc.). These studies, especially with children, will make a significant change for the social behaviour.

BSNN: The partner team has prepared and has been using information materials promoting well established and effective methods for reducing marine litter. The partner team will continue promotion of those methods with local communities and authorities, will provide data and raise awareness on methods for improvement of waste collection and waste and pollution prevention. The team will further disseminate information about the accumulation areas on the coast and suggest solutions to remove/mitigate solid waste. Substantial progress in achieving objective 3.

The survey will examine baseline marine litter understanding, attitudes, and behaviours of stakeholders in the four Black Sea countries at the beginning of the project, outline tendencies and prospects, and help assess the impact of project interventions (information, training, knowledge-based activities, research, networking etc.) at the end of the project, with the second survey.

The survey will help partners to choose appropriate awareness methods and design activities suitable for the target groups in the respective country. The methods and tools for awareness raising, the basis of activities with the different target groups, suggested by PP6 team and experts include:

- 1.Personal communication: Public meetings/debates with community members, fishermen, villagers, housewives etc. what is marine litter, why there is a need to reduce it and importance of being aware of the consequences for the environment, its impacts on human health and local economy, what are the benefits of reducing waste, proper disposal of waste, reduced use of plastics, separate collection of plastics etc.
- 2. Training activities for local people and decision makers: These activities have been postponed to the third period of the project implementation.

LP (PP1):

- 1. GA.T.4.2.1. One high school (88. Cumhuriyet High School) was visited and they trained about marine litter pollution, its impacts on our environment and future (546 participant students).
- 2. GA.T.4.3.1. One fishermen cooperative was visited and they trained about how marine litter impact their environment, job and future. The sources of the litter were also explained to them (24 fishermen)
- 3. GA.T.4.3.1. One women training activities was organised and their impact to stopped litter pollution were discussed. In addition to that the importance of the recycling were explained and how their efforts diminished the litter pollution and increase recycling of the litter were explained (21 women). After this activity, one of the participant who is teacher in the high school was impressed very much and she play key role to revise her school (88. Cumhuriyet High School) by means of training of the students (she invited us for training). She has been put recycling bins in each class of the school and is controlling if the bins regularly fill or not.

IBEDC (PP2):

- 1. A.T.4.2-IBEDC have held 2 offline (face to face) trainings in schools (2), while trainings 51 school children were trained about raise awareness in marine litter issues. They got useful information and introduced with essential issues of marine litter.
- 2. A.T.4.3.- IBEDC have held 2 trainings for raising awareness of adults, with participation of 76 persons (General Public-Local Population and Housewives of Chorokhi river) that found out more information about marine litter and their impact on marine environment. Also, they suggested actions that can be implemented on the beach to make people keep the beach clean and to inform them about marine litter aspects;

MN (PP3):

Monitoring of litter on the coastline quantify and characterize litter pollution and provide comparable datasets to support national and regional assessments of marine litter. MN prepared the report for marine litter survey. The data collected were also uploaded in Emodnet platform. The report was sent to relevant stakeholders and institutions (ministry, authorities) that are able to implement actions and measures to reduce the marine litter quantities.

For the trainings implementation GAT4, due to the Covid-19 pandemic, partners discussed some alternatives for the effective implementation in order to organize in time and in safety these trainings.
