Management:

The LitOUTer project together with its partners was doing as planned. All groups of activities (GA) and the underneath activities are in progress as planned. This period is covered from February to May 2022. During this period, the management activities based on partners are listed below.

Communication with the partners in many ways (phone, whatsup, e-mail, zoom meetings, and face-to-face meetings) were supplied and problems if any were solved. The harmony with the project partners is good.

LP: The LitOUTer project management in the LP consisted of;

- 1. The lead partner was done all its responsibilities related to producing awareness materials such as toys (designed, production and distribution), and play cards (designed, produced manual, and playcards themselves and puzzles accordingly) production and distribution. The partners used them for their awareness activities.
- 2. Sent the playcards to the partners from the Office and Administration budget of LP.
- Three partner meetings and one KTU team meeting were organised (LP-Attachment-1 Partner meetings and LP-Attachment-2 KTU meeting).
- 4. Procurement plan was prepared for project (compiled from partners procurement plans) for this period (Attachment-LitOUTer-Procurement Plan: List Of Services/Supplies/Works To Be Purchased Within The Project).
- 5. The interim report period is not ended during this period so clarification requirements and communication with partners were still continued.

The meeting with the decision-makers from local to the municipalities, governors, and Mayors have been organised. The activities will continue. Here is each partner activities were listed;

- 3. There was a campus clean-up activity done by middle school, high school, and university students on the KTU-main campus. The rector and some academicians have also participated. The number of participants was 105 (LP-Attachment-4 Clean-up activities).

GAT3: Up to present progress report 50% of this GA has been completed

LP:

- 1. A modelling workshop was done in Trabzon in 17-18 March 2022 participating with partners and stakeholder in Trabzon (LP-Attachment-6 Modelling workshop-LP).
- 2. This GA is directly related to the modeling/aminating of the Black Sea current system and also litter movement driven by wind.
- 3. The animation of the whole Black Sea current was done. In addition to that four river discharged to the Black Sea and their load related to the litter pollution were also modelled.
- 4. The first report was submitted by external experts to the LP.
- 5. The four rivers are the Coruh River (GE), Sürmene River (TR), Kamchiya River (BG), and Danube River (RO).
- 6. The first report is attached (LP-Attachment-9 GAT3-First Report).
- 7. Each river discharged was run according to 8 different wind directions that are, North (N), West (W), East (E), South (S), NorthWest (NW), NorthEast (NE), SouthWest (SW), and SouthEast (SE). The results were demonstrated in the report.
- 8. The participation of the IO-BAS, BSNN, NIMRD were online but MN and IBEDC were participated in place.

IO-BAS:

IO-BAS participated the modelling workshop via online.

MN:

Two members of the Mare Nostrum team participated at the modelling marine litter training, organized in March, in Trabzon, by LP.

BSNN:

BSNN participated online in one-day workshop on GIS modelling in Trabzon D.T.3.2.2 - workshop on ml GIS model

GAT4: Up to present progress report 75% of the total project activities have been completed

These GA activities have been related to the stakeholder's training. In this GA, the main target groups are students and adults with have much different expertise/knowledge. The job groups are fishermen, tourism sector, religious leaders, teachers, women, and the marine sector. In each partner have been organised training/awareness activities with them.

LP:

- 1. Four different activities were organised for children/student in different age groups. The total participant number was 283 (LP-Attachment-7 Training activities -students).
- 2. The another awareness meeting activity was done with mariners and the total participant number was 26 (LP-Attachment-8 Training report-adults).

IBEDC:

- 1. A.T.4.2-IBEDC have held 1 offline (face to face) trainings in Tkhilnari 1 Public Shool of Khelvachauri Municipality, while trainings 40 school children were trained about raise awareness in marine litter issues. They got useful raise awareness materials, information and introduced with essential issues of marine litter.
- 2. A.T.4.3.- IBEDC have held 3 offline trainings for raising awareness of adults, with participation of 109 persons (Georgian Maritime Academy; Representatives of enterprises and Condeminium of Batumi City Hall, General Public-Local Population and Housewives of Chorokhi river) that found out more information about marine litter and their impact on marine environment. They got useful raise awareness materials as well as. Also, they suggested actions that can be implemented on the beach to make people keep the beach clean and to inform them about marine litter aspects.

MN:

- 1. Organized 11 trainings (2 for children, 9 for teachers and students) during which 546 participants were trained about marine litter
- 2. Carried out two marine litter beach surveys, one in February 2022 and one in April 2022.

IO-BAS:

1. There were two activities organised in this period (IO-BAS-Attachment-1 Training activities).

NIMRD:

At the time of submitting the fifth progress report (PR5), the following activities of the total project activities have been completed by NIMRD:

- 1. Local young people represented by the university students (2 meetings)

- 4. Local religious community (1 meeting)

The training activities of stakeholders (activity AT4.2 and AT.4.3) are in progress; the training focused on local people and decision makers such as citizens, local school teachers, and children in the local areas will be done in the next of period of the project implementation. Also, some schools were already identified and preparing for training around 150 children starting in early September 2022 (NIMRD-Attachment-2 DT4.2.1- Training-school).

BSNN:

- D.T.4.3.1 1 meeting with 13 coastal municipal stakeholders on 21.03.2022 with focus on good practices on reduction on household waste (1 meeting/13 participants)
- D.T.4.2.1 The targeted number was completed (target 250/5 achieved 283/7)

Communication: In this period 75% of the total project activities have been completed.

LP:

Project Specific Objectives	Explanation on the level of achievement
1.Raising awareness and responsibility of the stakeholders to reduce marine litter	LP: In the project, the awareness/training activities were made a great sound. We accepted many invitations to give a training meeting, especially in schools. The reactions of the stakeholders were great and very collaborative. They realised that their normal habits are sometimes wrong and they promise themselves to try to change.
	IBEDC: While the reporting period of the project, part of stakeholder manager units was visited and were explained our project activities. They were all agreed and they were declared to support our activities. They were also given some idea about how we can reach more easily to their sectors. The activities according to the different stakeholder groups were planned. In a short while, the field studies will be started. The aim of delaying these activities is that we may have a chance to do face to face with our stakeholders after diminishing pandemic limitations.
	All the project activities implemented while the project are contributing to increase the awareness of stakeholders, especially when you use concrete examples and when you put them directly in contact with the problem of marine litter.
	MN: All the activities implemented during the project are contributing to increase the awareness of stakeholders, especially when you use concrete examples and when you put them directly in contact with the problem of marine litter.
	IO-BAS:
	Completion of training course under GAT2 (carried out 25.02.2022 as online meeting with 63 participants within the target groups). Participation in a training course, organized by partners "Litter dispersion modelling workshop" - Workshop for modelling of litter movement (17.03.2022) and Workshop held in Constanta, Romania (15-16.04.2022) along with a Steering comity meeting. Completion of training course under GAT4 carried out at high-school "P. Yavorov" - 15.04.2022. Completion of Workshop involving partner and stakeholders held on 16 th - 17 th May 2022 at Golden Tulip - Varna under GAT2 - Awareness methodology for marine litter.
	NIMRD: Since the project started, all stakeholder manager units were visited and were explained our project activities. They were all agreed and they were declared to support our activities. They were also given some idea about how we can reach more easily to their sectors. The activities according to the different stakeholder groups were planned. We will re-start training activities in July 2022.
	BSNN: Considerable progress has been made in raising the

awareness of key stakeholders promoting improvement in waste management practices, adoption of good practices for marine litter reduction, change in consumer attitudes and awareness of businesses and producers' responsibilities for sustainable use of resources. The partner organised 18 meetings and trainings with total of 528 participants from different places along the coast, different age and stakeholder groups, disseminated over 1300 awareness and publicity items (toys, t-shirts, posters, leaflets, brochures), organised press conference at BTA national news agency in Sofia and supported over 10 media publications and social media posts in thematic groups. Very substantial progress in achieving objective 1.

Determination of the proportions of the potential sources for the marine litters

LP: The recycling requirements and the infrastructure necessities were underlined by stakeholders. The requirements of the stakeholders were forwarded to the decision-maker, especially municipalities. The importance of the separation at home was underlined and also stopping the single used plastic materials are crucial to reducing litter pollution in the environment were also specified.

IBEDC: After the literature survey in the first progress report, there were no activities for this.

MN: Marine litter monitoring studies carried out on the beach are contributing to the process of seeing the situation on Romanian beaches, but are not especially seeing the potential sources, can be only assumptions can be made. All the dates/information are entered in Emodnet database.

IO-BAS: No any activity related to this section.

NIMRD: After the literature survey in the first progress report, there were no activities for this. We have an in-house supported project related to riverside and seaside litter collection project are supporting this project with its results.

BSNN: The partner is preparing for field studies in the summer and autumn. The partner team has reviewed the information and selected sampling areas for beach litter monitoring and clean-up activities, making plans on how to and ample area and plan how to describe the marine litter sources, ways of transport, and options for field studies to measure quantities and top pollutant items. Considerable progress has been made in achieving objective 2.

Development of methods for mitigation and determination of cleaning strategies of marine litters

LP: In the awareness/training activities, there were many samples that demonstrated on litter pollution impact and the harmful impact on the human being and also environment. Audio visual materials that were produced for the project were also very effective in understanding the harmful effects of litter pollution.

IBEDC: These actions and measures will be developed after the activities carried out with stakeholders workshops and the trainings for them. Also, the open-air exhibitions will represent an important factor to see the citizen's perspective. The meetings with stakeholders are contributing at this objective, trying to find together ways to reduce the marine litter problem.

MN: These methods will be developed after the activities carried out with stakeholders (like workshops), but also after the trainings for them. Also, the open-air exhibitions will represent an important factor to see the citizens perspective. The meetings with stakeholders are contributing at this objective, trying to find together ways to prevent the marine litter problem.

IO-BAS: IO-BAS is currently in process of organization of Beach cleaning action involving stakeholders within the target groups.

NIMRD: When the awareness activities will start in the sampling area, together with the other activities (extra bins, separation of litters (at least plastics, papers), the awareness level will be improved. The awareness studies planned to be carried out in the sampling area will be increased with the support of decision makers (such as, extra bins, recycle bins etc.). These studies, especially with children, will make a significant change for the social behaviour.

BSNN: The partner team has prepared and has been using information materials promoting well established and effective methods for reducing marine litter. Most recently the BSNN team has focused on good practices for reducing plastic waste at hotels and coastal tourist service paces; and good practices for reducing household waste and food waste. Those two specific sets of good practices have been selected for their considerable potential for replicability and effectiveness in the reduction of marine litter.

The partner team will continue promotion of those methods with local communities and authorities, tourist businesses, experts and NGOs and will provide data and raise awareness on methods for improvement of waste collection and waste and pollution prevention. The team will further disseminate information about the accumulation areas on the coast and suggest solutions to remove/mitigate solid waste. Substantial progress in achieving objective 3.

During the project, we had some delays organizing workshops. But since March 2022 we organised four workshops and many meetings with stakeholders and also partners. Now we have almost caught the schedule of the project.

The interim report period was also difficult. Nowadays we are waiting for the MA decision.

In this project implementation period, two partners had delay at the workshop organisation (LP and NIMRD (PP5)). This delay will not affect project implementation negatively. The revised schedule is below. The first workshop was used to be held in April 2021 by LP but the Covid-19 pandemic limitation, the date postponed to September 2021. The other workshop also was not organized in June 2021 but it will be organized to November 2021 by PP5 as planned. The others will be organized as planned in the project implementation schedule.

In the reporting period PP6 BSNN held a number of online, open-air and physical presence trainings/meetings - observing the national Covid-19 rules at the specific time (online meetings, small groups of physical presence meetings, disinfection etc.)

In the reporting period PP6 BSNN organised some hybrid events and attended some project workshops in hybrid format.
