	BSNN: Significant progress has been made in raising the awareness of key stakeholders promoting improvement in waste management practices, adoption of good practices for marine litter reduction, change in consumer attitudes and awareness of businesses and producers' responsibilities for sustainable use of resources. The partner organised 21 meetings and trainings with total of 568 participants from different places along the coast, different age and stakeholder groups, disseminated over 1300 awareness and publicity items (toys, t-shirts, posters, leaflets, brochures), organised press conference at BTA national news agency in Sofia and supported over 25 media publications and social media posts in thematic groups. Very significant progress in achieving objective 1.
2. Determination of the proportions of the potential sources for the marine litters	LP: During the awareness activities, they all know the sources of litter pollution. Although they blame the decision-makers and lack of the infrastructure, they know deeply they have also their fault.
	IBEDC: While the awareness activities, stakeholders revealed knowledge about the sources of litter pollution. The recycling requirements and the infrastructure necessities were underlined by stakeholders. The requirements of the stakeholders were forwarded to the decision-maker, especially municipalities. The importance of the separation at home was underlined and also stopping the single used plastic materials are crucial to reducing litter pollution in the environment were also specified.
	MN: Marine litter monitoring studies carried out on the beach are contributing to the process of seeing the situation on Romanian beaches, but are not especially seeing the potential sources, can be only assumptions can be made. All the dates/information are entered in Emodnet database.
	IO-BAS: Litter monitoring and clean up has been done close up the Kamchia River mouth, at the sandy beach. The River is one of the main litter contributors to the sea.
	NIMRD: After the literature survey in the first progress report, there were no activities for this. We have an in-house supported project related to riverside and seaside litter collection project

	BSNN: The partner planned field study and prepared information for the selected sampling areas for beach litter monitoring and clean-up activities, preparing information about sources and top pollutant items using EU methodology for beach litter monitoring and the citizen science Marine Litter Watch App of EEA. The partner will describe the marine litter sources, ways of transport and options for prevention or littering of the beach. Substantial progress has been made in achieving objective 2
•	LP: During the project implementation period, the main output is to stop single-used materials. Separation of litter should be started at home and recycling must be supported by the government based. The infrastructure must support public efforts. The awareness materials were very helpful for understanding the situation in the environment and even marine animals.
	IBEDC: These actions and measures will be developed after the activities carried out with stakeholder's workshops and the trainings for them. Also, the open-air exhibitions will represent an important factor to see the citizen's perspective. The meetings with stakeholders are contributing at this objective, trying to find together ways to reduce the marine litter problem.
	MN: These methods will be developed after the activities carried out with stakeholders (like workshops), but also after the trainings for them. Also, the open-air exhibitions will represent an important factor to see the citizens perspective. The meetings with stakeholders are contributing at this objective, trying to find together ways to prevent the marine litter problem.
	IO-BAS: Working with stakeholders in the frame of workshops, open-air exhibition in order to receive back opinion from trained people. Based on those new methods will be developed.
	NIMRD: When the awareness activities started in the sampling area, together with the other activities (extra bins, separation of litters (at least plastics, papers), the awareness level is getting improved. The awareness studies planned to be carried out in the sampling area will be increased with the support of decision makers (such as, extra bins, recycle bins etc.). These studies, especially with children, will make a significant change for the social behaviour.
	BSNN: The PP6 team has prepared and used information materials promoting well established and effective methods for reducing marine litter. The team of BSNN has focused on good practices for reducing plastic waste at hotels and coastal tourist service paces; and good practices for reducing household waste and food waste. Those two specific sets of good practices have been selected for their considerable potential for replicability and effectiveness in the reduction of marine litter and circularity.

The partner team has been promoting those methods with local communities and authorities, tourist businesses, experts, an NGOs. The team will further disseminate information about th accumulation areas on the coast, use project information an collect suggestions from stakeholders on effective solutions t mitigate the solid waste problem. Significant progress has bee made in achieving objective 3.

- 4. The preparation of the symposium (31 October-2 November 2022 held in Trabzon) was started in this period.
- 5. The second round questionnaire was translated into Turkish and was sent a link to the stakeholders to fill. Since then more than 700 questionnaires were filled out by stakeholders (LP-Attachment-Questionnaire).
- 6. One clean-up activity was also organized in the Beşirli District coast, Trabzon (22 participants) (LP-Attachment-Field study)

IBEDC (PP2):

- 1. Organized the workshop "RAISING AWARENESS AND MARINE LITTER REDUCTION IN THE BLACK SEA", in Batumi, Georgia. The event was composed by one-day workshop, on September 22th 2022, at Hotel Radisson Blu Batumi, and one day dedicated to study visits, on 23th September 2022, together with project partners and their invited stakeholders. The workshop was organized in offline format, at the conference room of Hotel Radisson Blu Batumi. In total, 50 participants attended the workshop. During the workshop were discussed the issues related to marine litter in Romania, the project activities and the main result obtained at this point. The workshop was attended by project partners and their invited stakeholders, institutions, and authorities from Batumi and Khelvachauri Municipalities, NGO's, teachers. During the second day, on 23th July 2022, took place the study visits with the partners and their invited stakeholders. The visit started in Batumi School EURO 2000-project stakeholder, where pupils arranged exhibition on marine litter issues and did presentations on Environmental protection issues for the project team. The second visit was at Tkhilnari Public School of Khelvachauri Municipality, where schoolchildren and teachers hosted project team and demonstrated good knowledge in marine litter issues. IBEDC team has gifted awareness materials toys and play cards to schoolchildren of above mentioned schools;
- 2. Participated at the workshop and Open-air exhibition organized in Tulcea, Romania in July 14-15.2022.;
- 3. Organized the open-air exhibition in Batumi in 26-27 September 2022 (IBEDC-Attachment-Open air exhibition). During the two days of the exhibition, the IBEDC team spoke to the visitors about the impact of marine waste, their situation on the Georgian coast of the Black Sea, as

well as about sustainable alternatives that they can use to reduce their impact on the environment. The Open-air Exhibition was visited by more than 500 persons (children, adults, tourists and citizens) that saw the information about marine litter presented on the panels, discussed with project team, and received more information about the situation of marine litter in Georgia, but also about what they can do, in their daily life, to be more eco-friendly, helping in this way to also prevent the marine litter from the beaches;

- 4. During the reporting period, awareness materials such as leaflets, brochures, T-shirts, toys, play cards, and posters were disseminated to the stakeholders according to their interests;
- 5. Printed the project materials in Georgian language and the ones in English. All the materials prepared in the current period, were printed in June, as follow: 100 brochures/leaflets (GE Brochure 70 pcs., EN Brochure 30 pcs.,), T-shirts 50 pcs, Notepad 50 pcs, Folders 50 pcs, Branded pens 50 pcs, Certificates 50 pcs.;
- 6. The second round questionnaire was translated into Georgian and was sent a link to the stakeholders to fill.

MN (PP3):

- 1. Organized the workshop "MARINE LITTER PROBLEM IN THE BLACK SEA TOGETHER FOR COMMON SOLUTIONS", in Tulcea. The event was composed by one day workshop, on 14th of July 2022, at Hotel Delta Tulcea, and one day dedicated to study visits, on 15th of July 2022, together with project partners and their invited stakeholders (MN-Attachment-Workshop in Tulcea; MN-Attachment-Workshop report)). The workshop was organized in hybrid format, physical at Hotel Delta, Tulcea, conference room Toma Caragiu, and online on Zoom. The format was chosen to be in this way, offering the opportunities for the participants, from others location then Tulcea, to attend the event. In total, 115 participants attended the workshop, 38 physical (in the conference room) and 77 online, on Zoom. During the workshop were discussed the aspects related to marine litter in Romania, the project activities and the main result obtained at this point. The workshop was attended by project partners and their invited stakeholders, institutions, and authorities from Tulcea and Constanta, NGO's, teachers from Constanta, Tulcea, Braila and from others Romanian county's. During the second day, on 15th of July 2022, took place the study visits with the partners and their invited stakeholders. 26 participants attended this study visit in Tulcea and county. The visit started with the visit at Deltaica Factory, fish products producer, which try to use friendly equipment's. The second visit was at Mechanical-biological waste treatment plant (TMB), located in Mihai Bravu, Tulcea county. At the end of the visit the group was back to Tulcea and had the chance to visit the open-air exhibition organized by Mare Nostrum and the Ecotourism Museum Center "Danube Delta", were they discovered the biodiversity of Danube Delta and visited the aquarium.
- 2. Participated at the workshop and exhibition organized in Batumi, in September 22-24.09.2022. Mare Nostrum presented the activities carried out in the project. Unfortunately, at this workshop was impossible to join with a stakeholder, due to the short time in which we received the invitation (the organization of this workshop was difficult for our partner to organized it due to the waiting time for the response related to the payment of interim). Joining at the workshop with a stakeholder, in the condition of planning the trip with 1 week before, it was extremely far over the budget we have for this aspect.
- 3. Organized the open-air exhibition in Tulcea (MN-Attachment-Open air exhibition). During the two days of the exhibition, the Mare Nostrum team spoke to the visitors about the impact of marine waste, their situation on the Romanian coast of the Black Sea, as well as about sustainable alternatives that they can use to reduce their impact on the environment. The Open-air Exhibition was visited by more than 600 persons (children and adults) that saw the information about marine litter presented on the panels, discussed with project team, and received more

information about the situation of marine litter in Romania, but also about what they can do, in their daily life, to be more eco-friendly, helping in this way to also prevent the marine litter from the beaches. After the two days of open-air exhibition, the Ecotourism Museum Center "Danube Delta" - Aquarium TULCEA, hosts this exhibition in the premises for the summer and they are hosting this exhibition also in the autumn. Also, the panels with information presented during the exhibition, were created also like posters, and are exhibited at Sulina Visitors Center for an indefinite period for all those who visit the center (tourists and citizens).

- 4. Had 1 meeting with stakeholders in Tulcea, with Administration of the Danube Delta Biosphere Reserve, "Danube Delta" Ecotourism Museum Center. Discussions were held with them about the problem of marine litter in the delta area. The discussions focused on the current situation of the waste in the area, but also how future activities can be carried out in the area, with the aim of increasing the level of awareness regarding the problem of marine litter and the importance of the area and its protection (MN-Attachment- Meeting with stakeholders).
- 5. Printed the project materials in Romanian language and the ones in English. All the materials prepared in previous period, were printed in June, as follow: 2 roll-ups, 100 posters (30 project posters and 70 posters for the beach), 1250 brochures/leaflets (RO Brochure 200 pcs., EN Brochure 50 pcs., RO Leaflet 800 pcs., EN Leaflet 200 pcs.), 1250 pcs playing cards origami game (MN-Attachment-Awareness materials).
- 6. Disseminated the project materials during various activities. All the project materials were disseminated during various activities like the openair exhibition organized in Tulcea, at the workshop organized in Tulcea, during a summer school that we had in collaboration with other countries (having one topic related to marine litter), during some exhibitions and conferences where we were invited. The posters made to be disseminated to the beach operators, were distributed to them and displayed in front of their bars, on 8 beach sectors in Romania, in order to contribute to informing the citizens about people's behavior towards the waste that ends up on the beach.
- 7. Translated the second round of questionnaires (online, short, for schools) and started to apply them in September.

IO-BAS (PP4):

- 1. General public 50 participants (citizens, tourist industry, public administration) under GA T4. The movies and pictures from our project activities were demonstrated to the participants. The discussions were focused around the prevention, responsibilities and mitigation measures against litter.
- 46 participants from Black Sea Basin Directorate MOEW, deputy Minister of MOEW, IO-BAS scientists and staff, and volunteers took part at the beach clean-up at Kamchia River mouth and beach (GAT4). Over 300 kg litter were collected from the beach. (https://www.bsbd.org/v2/bg/index.html?offset=6)
- 3. We were not present at workshop and exhibition organized in Batumi, in September 22-24.09.2022, but we participated at the steering group meeting -online. Since we were pressed by short notice and lack of invitation and agenda on time and the very high prices of the air tickets we were not able to organize the business trip.
- 4. Disseminated the project materials during various activities. All the project materials were disseminated during various activities like training, at the beach cleanup, during some exhibitions and conferences where we were invited. Translated the second round of questionnaires (online, short, for schools). We are starting to apply them shortly.

NIMRD (PP5):

1. NIMRD contributed to the generation of the most planned awareness materials for children consisted mainly into visual materials (toys, play

cards, animation film/cartoon, t-shirts and hats), as well as the published press documents (banners, roll-ups, leaflets, posters and stickers) to be distributed to the stakeholders and to be used in each project activity (e.g., meetings, field studies, and workshop). The other materials started to be designed and their production will be completed in next coming months:

- 2. Two (2) banners, fifty (50) stickers, one (1) roll-up, 625 leaflets, and 100 posters.

BSNN (PP6):

- 2. BSNN was not able to participate in the workshop in Batumi, Georgia due to involvement of the team members in other project event international conference planned in 2021 but sent a presentation to inform of project activities.
- 3. BSNN started dissemination of information about the International Symposium on Marine Litter in the Black Sea, to be held 31.10 02.11.2022 in Trabzon, Turkey.
- 4. BSNN presented to partners and started work on the second round of questionnaires for the survey to be finalized in the next reporting period.
- 5. BSNN planned the Open-air exhibition, planned completion of the production of awareness materials to be disseminated at the exhibition and at other activities.
- 6. BSNN planned meetings with representatives of stakeholders under GA2 to complete the numbers of meetings and target number of stakeholders involved.
