BSNN:

1. Took part in the International Symposium on Marine Litter in the Black Sea, held 31.10 - 02.11.2022 in Trabzon, Turkey and in the Project Workshop 3-4.12.2022; BSNN ensured 4 presentations - 3 in person (2 team members and 1 stakeholder) and 1 online of scientist stakeholder.

2. BSNN and partners worked on the second round of questionnaires for the second survey and finalized it in the reporting period.

3. BSNN organised and held an Open-air exhibition in Burgas, on the southern coast on 16 -17.11.2022; as planned the team disseminated awareness materials.

4. BSNN planned second series of awareness materials, had it approved by JTS as exact types and numbers and completed the production of the following awareness materials: pictures and infographics of marine litter in the sea, double-sided 500 items; pictures and infographics with marine litter pathways, double-sided 500 items; pictures for awards, single-sided 500 items ; paper banners for October 31, 300 items; flags double-sided printing, 250 items (pictures of the new series of awareness materials attached; also shown on other pictures at trainings); those awareness materials are to be used in awareness, training and dissemination activities.

5. BSNN held a number of meetings under D 2.2.1 with representatives of stakeholders under GA2 to increase awareness and involve more representatives of the target groups in current project and also in view of follow up activities. Those were as follows: 6 meetings in places on both the northern and the southern coast (1 meeting in Malko Turnovo, southern coast 24.11.2022 - 8 participants, focus on plastic waste reduction;1 meeting with church community leaders at the St. Procopius of Varna Church, 25.11. 2022 - 6 participants, focus on Sunday school and church community training and involvement; 1 meeting in Burgas 16.12.2022 - 8 participants from administrations, focus on plastic waste reduction; 1 meeting in Varna 21.12.2022 - 10 participants, focus on waste reduction, circularity and follow up of project, 1 meeting in Varna on 22.12.2022 with leaders of Muslim community at district muftiship - 4 participants, focus on awareness in future activities for children, students, housewives; 1 meeting in Varna on 20.01.2022 - 4 participants, teachers working on Erasmus + project for ocean literacy, training on

circularity and awareness products of LitOUTer; focus on future trainings with students and follow up). D.T.2.2.2 - (target 10 trainings/100 participants; achieved 12 meetings/122 participants.

6. This period, 6 trainings/40 participants; total 12 trainings/122 participants

GAT3: Up to present progress report 95% of this GA has been completed

1. Litter transportation senarios (DT3.2.1) were produced for selected river from partner countries and the total number of the senarios were 100.

2. The workshop related to the modelling was organised in the previous period and this activity completed (DT3.2.2.).

1. Insitu training activity was completed in the last year (DT3.1.1.).

GAT4: Up to present progress report 95% of the total project activities have been completed

LP: Under this GA all activities were completed. In the extension period, there will be two training activities planned.

1. GAT4.2.1. (Local meetings, school visits, field study, and other activities) activities were completed. 10 schools were visited and gave lectures about litter pollution and its impact on their health and life. The overall participant number was 1098.

2. Training activities for local people and decision-makers (DT.4.3.1.) were completed. The number of participants and the number (500 participants) of activities reached the defined number.

3. In the extension period two more training activities will organised.

4. In this GAT4, the responsible partner PP3 (MN) prepared a project base report and analysed the outputs.

	NIMRD: All the activities implemented during the project are contributing to increase the awareness of stakeholders, especially when you use concrete examples and when you put them directly in contact with the problem of marine litter.
	BSNN: Very significant progress has been made in raising the awareness of key stakeholders promoting improvement in waste management practices, adoption of good practices for marine litter reduction, change in consumer attitudes and awareness of businesses and producers' responsibilities for sustainable use of resources. BSNN organised 33 meetings/trainings/workshop with total of 930 participants from different places along the coast, different age and stakeholder groups, disseminated over 1300

2. Determination of the proportions of the potential sources for the marine litters	LP: The main resources of marine litter are from land-base. Irregular landfills, lack or less recycling infrastructure, and lack of awareness are the main reason for the increasing marine litter.
	IBEDC: IBEDC has carried out Marine litter monitoring studies on the beach were contributing to the process of seeing the situation on Georgian beaches according to certain methodology, but are not especially seeing the potential sources, can be only assumptions can be made. While the awareness activities, stakeholders revealed knowledge about the sources of litter pollution. The recycling requirements and the infrastructure necessities were underlined by stakeholders. The requirements of the stakeholders were forwarded to the decision-maker, especially municipalities. The importance of the separation at home was underlined and also stopping the single used plastic materials are crucial to reducing litter pollution in the environment were also specified.
	MN: Marine litter monitoring studies carried out on the beach are contributing to the process of seeing the situation on Romanian beaches, but are not especially seeing the potential sources, can be only assumptions can be made. All the dates/information are entered in Emodnet database.

	NIMRD: After the literature survey in the first progress report, there were no activities for this. We have an in-house supported project related to riverside and seaside litter collection project are supporting this project with its results.
	BSNN: The partner held Field study and prepared information from the selected sampling areas for beach litter monitoring and clean-up activities, preparing information about sources and top pollutant items using EU methodology for beach litter monitoring and the citizen science Marine LitterWatch App of EEA. The partner disseminate information about marine litter sources, ways of transport and options for prevention or littering of the beach. Outdoor training activities have been held to support this

mitigation and determination of cleaning strategies of marine litters	LP: In the project, we used many methods for raising public awareness. The main goal of the project was to reach as many as possible stakeholder and it has been done. During the training activities, it was indicated that the mitigation of litter produced is the most important issue. And, mitigation of litter pollution should start from an individual base to enlarge community level.
	IBEDC: These actions and measures will be developed after the activities carried out with stakeholder's workshops and the trainings for them. Also, the open-air exhibitions will represent an important factor to see the citizen's perspective. The meetings with stakeholders are contributing at this objective, trying to find together ways to reduce the marine litter problem
